Prior to joining ICF, Dr. Silberman worked for eight years at the Department of Justice where he was a Senior Economist and an Assistant Director in the Economic Policy Office of the Antitrust Division. As an Assistant Director from April 1981 to September 1982, his responsibilities included the following:

- Supervised staff economists conducting investigations and preparing cases in the fields of banking, communications, railroads, airlines, energy, and foreign commerce.
- Participated in drafting and reviewing Antitrust Division filings before the Federal Communications Commission, Interstate Commerce Commission, Federal Reserve Board, and Securities and Exchange Commission on topics that included the sale of satellite transponders, the MTS/WATS rate structure, deregulation of rail rates for export coal and an end to ceilings on interest rates.
- Acted as lead economist for certain cases and investigations, including *U.S.* v. *Virginia National Bankshares*.

As a senior Economist in the Economic Policy Office, Dr. Silberman's accomplishments included the following:
